REMINDER—papers will be published from your original submission with minimal editing and/or reformatting. If English is not your native language, you will need to have your technical paper edited by a native English speaker prior to submission. A clear and concise submission will ensure a smooth peer review process. Failure to comply with the submission guidelines may prohibit your technical paper from being published.

Basis for Rejection of Papers

Papers will be peer-reviewed for technical and scientific merit and can be rejected for the following reasons:

- Insufficient data and/or experimentation;
- Subject matter does not fall within the field of AFS activities;
- Contents are of a commercial nature, trivial or over expanded;
- Subject matter is of a speculative nature; and/or
- Content is defective in literary form, continuity of thought and clarity of expression.

Papers that do not adhere to the guidelines will <u>not</u> be accepted for publication. The respective AFS Program and Papers Committee reserves the right to reject papers on grounds other than those listed.



Submission Format

Text

- **Title**—upper- and lower-case font, centered at the top of the first page.
- Author Information—author(s) names(s) and affiliation/city, state & country in upper and lower cases. Use the author's first name, middle initial, and last name.
- **Abstract**—75 to 150 words in length.
- **Keywords**—locate after the Abstract, up to 10 words.
- **Text**—single-spaced, <u>double</u> column, with 3/4-inch margins all around. Use Times New Roman 10-pt font for body text except in Title, Headings, and Captions. Use an extra line space between paragraphs; do <u>not</u> indent paragraphs or justify columns. Use tab key to align data; do not use the space bar. Text must flow from top-to-bottom, left-to-right.
- Do <u>not</u> use headers, footers, page numbers, linked references, or footnotes.
- **Columns**—left-justified.
- Graphics—all artwork, graphs and charts should be embedded in the text after it is cited. Do <u>not</u> wrap text around artwork or tables.
- References—list at the end of the paper. Follow the example in the AFS Paper Template.
- **Equations**—create equations in *Equation Editor* (found under the Insert/Equation tab) and number the equations consecutively. Left align the equation and right align the equation number.

Images, Charts & Tables

- All artwork must be <u>embedded in the text file after it is cited</u>. Artwork should be of the highest resolution possible; tables and graphs should be legible.
- **Tables**—do <u>not</u> use complex formatting/shading. If the table width spans two columns, follow the example in the *AFS Paper Template*.

Captions

- **Figure Captions**—must be a complete sentence, located below each figure, flush left. The figure should be located after it is cited in the text. Do not use a list of figures at the end of the paper. Follow the example in the *AFS Paper Template*.
- **Table Captions**—must be in phrase format and located above each table, centered. The table should be located after it is cited in the text. Do not use a list of tables at the end of the paper. Follow the example in the *AFS Paper Template*.

NOTE ON ARTWORK

Artwork that is not property of the author <u>must</u> be acknowledged (e.g., Artwork courtesy of ABC Co., Inc.). <u>It is the author's responsibility to obtain permission to use any artwork</u>, video, table, figure, photo, etc. that is not his/her property. Proof that the author has obtained permission to use this artwork must be included with the technical paper submission along with the signed AFS Author's/Speaker's <u>Copyright</u> form. If applicable, use the AFS Author <u>Copyright Permission for Rightsholders</u>



Measurement Units & Metric System

- **Temperatures**—must be in Fahrenheit (F) & Celsius (C). Fahrenheit units must be followed by Celsius units in parentheses. A <u>degree symbol</u> should be used only when referring to a <u>temperature differential</u>.
- Mechanical Properties—should be reported in MPa. (1 MPa = 0.1450377 Ksi)
- Metric & English Units—are both used in the text. Metric should be converted to English and vice versa.
- Inches and feet—use abbreviations (in., ft.), not symbols.

References-New AFS Style

All information from other literature <u>must</u> be cited as a reference within the text as a <u>number in square brackets</u>.[X] References are listed numerically at the end of the paper in the **REFERENCE** section. If available, please include DOIs as full DOI links in your reference list (i.e., https://doi.org/abc).

Commercialism

Papers and/or presentations containing commercialism will <u>not</u> be accepted for publication or presentation. Papers will be reviewed for commercialism as part of the peer review and editing process as follows:

- More than one reference to company or trade names will not be permitted.
- Unsubstantiated, subjective evaluations or claims will <u>not</u> be permitted.
- Direct comparisons with other products or companies will <u>not</u> be permitted.
- The selling price or cost of a product or service will not be permitted.
- Logos in artwork other than equipment photographs with nameplates will not be permitted.

AFS Policy on Authorship & Use of AI Technology

Large Language Models (LLMs) do <u>not</u> currently satisfy AFS authorship criteria. AFS policy <u>prohibits</u> naming of such "tools" as a "credited author on a research paper" because "attribution of authorship carries with it, accountability for the work, and Artificial Intelligence (AI) tools cannot take such responsibility.

- The submission of content created by AI, language models, machine learning, or similar technologies are prohibited unless it is a part of the formal research design/experimental analysis. It is not permitted without a clear description of the content created and the name of the manufacturer/model/version must be included. (Note: this does not include basic tools for checking grammar/spelling.)
- If these AI tools are used to create content or assist with manuscript preparation, authors <u>must</u> take responsibility for the integrity of the content generated by these tools. Authors must report the use of AI technology to create content in the manuscript submission in the Acknowledgments section.
